OVERVIEW

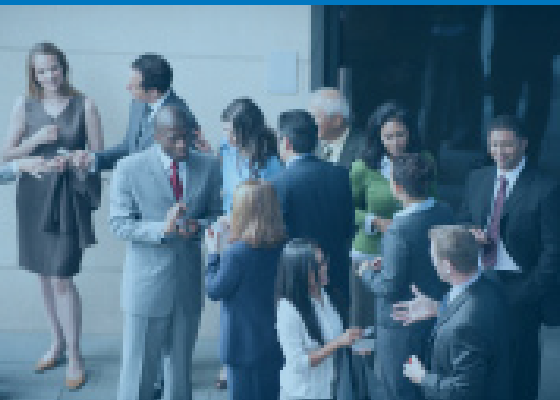
